Making use of the full range of the available literature, including case law, Treaty provisions and subsequent legislation, while also drawing upon relevant secondary literature from legal periodicals and the writings of political scientists, economists and other scholars who have studied the EC, the student is provided with a body of material both vast in scope and thorough in detail. Up-to-date documentation emanating from the organs of the Community is included as well, even where this does not take the form of completed legislation, in order to heighten the student's understanding and awareness of the most current dynamics of policymaking in the EC.

Textual explanations and evaluations of the many differing areas of EC law are related by the authors in detail, facilitating the use of the book as a primary text while enabling students to comprehend particular topics even where the book is used as an accompaniment to an existing text. Throughout the exegetical and interpretive sections of the text, the underlying theme that the EC must be related to the overall development of the Community as a whole is explored in a variety of ways within the discussion of the institutional and substantive law of the EC.
