The construction of dams and irrigation projects, the expansion of communication networks, urbanization and re-urbanization, the extraction and transportation of mineral resources, forced evictions in urban areas, and population redistribution schemes count among the many possible causes. Terminski aims to present the issue of development-caused displacement as a highly diverse, global social problem occurring in all regions of the world. As a human rights issue it poses a challenge to public international law and to institutions providing humanitarian assistance. A significant part of this book is devoted to the current dynamics of development-caused resettlement in Europe, which has been neglected in the academic literature so far.
